RULES & REGULATIONS

Eligibility: Anyone with a valid SD fishing license is eligible to fish in the tournament. Entry fee is \$225 per team until April 3. After April 3, \$325 per team! Contestants must check in at Rules Meeting Friday, April 9, 2010.

Tackle & Equipment: Artificial and live lures may be used. Each contestant may use two rods. Only two fisherman are allowed per boat. Boating entrants only.

Fishing Area: Lake Francis Case from Big Bend Dam at Ft. Thompson down to the Platte/Winner Bridge. All boats must leave and return from Cedar Shore Marina.

Fishing Hours: The tournament will be run in three flights starting at 7:00am with the last flight coming in at 3:30pm, Sat., April 10, 2010.

Scoring: The largest weight of five fish will win. **Each boat will be permitted to catch seven, tag seven, and weigh FIVE fish.** Two over 20 inches, the rest must be 15 inches minimum. All rules set by SD Game, Fish and Parks will apply. If you have seven fish tagged bring your best five to the scale, your other two fish will be released into a holding tank. All tags must be returned to the scale master.

Entry Fee: **\$225/team until April 3. After April 3, \$325/team.** Cash, Personal Check, Cashier Check or Money Order, or a valid Credit Card number with Expiration Date must accompany each entry form. All accepted entries will be notified by mail when checks clear the bank. **No Refunds!** Forms available at the Front Desk or online at www.cedarshore.com.

NOTE: Patrol boats will be in the area. No marine band radios or CB radios will be allowed to transfer information from boat to boat. Use of marine band and cell phones for emergencies only.
